## EMPLOYMENT COUNCIL FOR THE TEXTILE INDUSTRY

## FURTHER AGREEMENT

This further agreement, made and entered into in accordance with the provisions of the Labour Relations Act, 1985, between the Central African Textile Manufacturers' Association (hereinafter referred to as "the employers" or the "Employers' organization"), of the one part, and the Zimbabwe Textile Workers' Union of Zimbabwe (hereinafter referred to as "the employees" or "the trade union"), of the other part, being parties to the Employment Council for the Textile Industry, shall be read as one with the agreement published in Statutory Instrument 555 of 1983, as amended (hereinaster referred to as "the principal agreement").

1. Clause 8 of the principal agreement is amended—

(a) by the insertion of the words "discertification" after the word "registration" before the word "of" in the first line of subclause (5) (a).

2. Clause 9 of the principal agreement is amended—

(a) by the deletion of subclause (1) (ii);

(b) by the deletion of the words "unless exempted in terms of paragraph (b)" in subclause (2) (a) and the substitution of "Every employer shall pay to each of his employees wages which, if calculated on a weekly basis, are not less than the minimum set forth in subclause (3) applicable to employee's level and status as a learner or otherwise, or, if calculated on an hourly, daily or monthly basis, are no less than the amount arrived at by converting the prescribed minimum weekly rate in the manner laid down in Clause 12";

(c) by the deletion of subclause (2) (b);

(d) by the deletion of the word "normally" in subclause (8) and the substitution of "an employer who requires an employee to perform work ascribed to two or more levels shall pay to such employee the wage applicable to the highest of such levels.";

(e) by the insertion of the words "in terms of section 68 of the Act" after the word "suspension" in subclause (11).

3. Clause 10 of the principal agreement is amended—

(a) by the deletion in subclause (1) (f) of the word "dismissed" and the substitution of the word "suspended" in the last line;

(b) by the addition of a new subclause (1) (h) (iii) "in the case of a guard: that there are facilities that he

receives refreshments";

(c) by the deletion of subclause (1) (i) and the substitution of "an employee required to travel on duty shall be paid at his normal rate of pay up to the maximum of 12 hours payable per day";

(d) by the deletion of the proviso; (e) by the deletion of subclause (2) (g);

- (f) by the insertion of the words "in consultation with the Workers' Committee" after the word "may" before the word "cause" in subclause (5);
- (g) by the deletion of subclause (c) and the substitution of "Employees whose services are terminated or resign from employment before commencing vacation leave shall be entitled to wages and benefits due to them up to the time of such termination or resignation".
- 4. Clause 11 of the principal agreement is amended—
  - (a) by the deletion of subclause (1);
  - (b) by the deletion of subclause (3);
  - (c) by the deletion of subclause (4);
  - (d) by the deletion of subclause (6); (e) by the deletion of subclause (8) and the substitution by a new subclause (1) "No employer shall place all or some of his employees on short-time working

without prior written approval of the Minister of Labour, Manpower Planning and Social Welfare".

5. Clause 15 of the principal agreement is amended—

(a) by the deletion of the words "three days" and substitution of the words "one day" in the proviso in subclause (1).

6. Clause 17 of the principal agreement is amended—

- (a) by the deletion of subclause (1) (c) and the substitution of "An employer who employs a mother whose own child is under the age of thirteen years of age shall grant such mother time off for the purpose of taking such a child for treatment, provided that she produces a medical certificate or a certificate from a registered traditional healer immediately upon return to work. Such time off shall be deducted from the employee's sick leave entitlement in terms of clause 21 subclause (4) or (5) whichever is appropriate";
- (b) by the deletion of the whole of subclause (2); (c) by the deletion of "2" and the substitution of "3"

in subclause (3) (a).

7. Clause 18 of the principal agreement is amended-

(a) by the deletion of the words "but not less than a minimum amount equivalent to one day's pay at level 4 rates of pay" in subclause (1) after the word "expenses" and the substitution of the words "appropriate to the area of work-location" after the word "expenses".

8. Clause 19 of the principal agreements is amended-

- (a) by the deletion of subclause (2) and the substitution of "An employer shall permit an employee to proceed on vacation leave one month of his application therefor, and an employee who is entitled to vacation leave may be compelled to take such leave within one month of an instruction to do so from his employer.
- 9. Clause 21 of the principal agreement is amended—
  - (a) by the deletion of subclause (1) and the substitution of "If an employee becomes incapacitated and unfit for work owing to sickness or accident, he shall obtain a certificate from a medical practitioner or a registered traditional healer, setting out the cause which renders him unfit for work, and shall produce such certificate upon return to work";
  - (b) by the deletion of the words "has been in continuous service for more than three months or more, and" in subclause (4);
  - (c) by the insertion of the words "a registered traditional healer, or" after the word "practitioner" before the word "a" in subclause (8).
- 10. Clause 22 of the principal agreement is amended-
  - (a) by the deletion of "If an employee deserts or wrongfully terminates his employment without due notice, the employer shall pay the employee for the period during which the employee carried out his duties";
  - (b) by the deletion of provisos (i), (ii), (iii) and (iv).
- 11. Clause 26 of the principal agreement is amended—
  - (a) by the deletion in subclause (5) of the words "but, that, if he goes on pension at the retirement date of the policy, he shall no longer be entitled to a gratuity" after the word "clause".
- 12. Clause 23 of the principal agreement is amended by the deletion of subclause (d) (ii).

work-flow as soon as it is available.

## Conditions for Acceptance of Copy-

FAILURE to comply with any of the following conditions will result in the rejection of copy, and no responsibility can be accepted if such rejection should affect any date contained in such copy or any requirement of publication on a specific date.

Persons drafting any kind of notices are strongly advised to follow the guidance offered in—

(a) the Instructions Relating to the Drafting and Typing of Legislation (Attorney-General's Circular 1 of 1978); and

(b) the Manual of Style for the Drafting and Preparation of Copy, published by the Department of Printing and Stationery;

which two booklets are intended for complemental use.

In these conditions, other than where a particular kind of copy is specified, "copy" means copy for all matter contained in the Gazette itself and for subsidiary legislation issued as supplements to the Gazette.

1. (1) Other than by prior arrangement, only original

typing is accepted.

(2) Carbon-copies are not normally acceptable, other than in cases where the original typing has to be legally retained, elsewhere, as, for example, in the case of a proclamation.

(3) Computer print-outs are not accepted automatically, as discussion may be necessary with regard to the extra time and costs involved.

2. (1) All copy must be clear and legible, and there must be double or one and a half spacing between the lines.

(2) Any corrections or alterations made by the originator must be clearly effected in blue or black ink, using editorial marks—not proof-reader's marks:

Provided that any copy containing extensive alterations will be rejected.

3. (1) Copy must appear on one side only of each sheet of paper.

(2) Except as is provided in subsection (2) of section 8, paper must not exceed 210 millimetres in width.

(3) If copy comprises two or more sheets of paper, all sheets must be numbered consecutively, in arabic figures, preferably in the top right-hand corner.

(4) Where any matter is added after the copy has been prepared, and such additional matter results in one or more sheets being inserted between those already numbered, all sheets must be renumbered from there onwards—not, for instance, 7, 7a, 7b, 8, et cetera.

4. Photographic copy or copy produced on a duplicatingmachine may be accepted if it is abundantly clear.

5. (1) Should any copy-

(a) exceed 10 pages of double-spaced typing on size A4 paper; or

(b) contain tabular or other matter which involves complicated setting;

it will be classed as "lengthy" copy, and will be required to be submitted not less than 21 days before the date of closing for the Gazette in which it is to be published.

(2) Lengthy copy may be accepted at less than 21 days' notice if—

(a) the work involved is of a straight forward and non-tabular nature; and

(b) the total volume of work on hand for the time being permits its acceptance.

6. Notwithstanding anything to the contrary contained in

these conditions, any copy-

- (a) which is of national importance, and which is originated as a matter of urgent necessity, may, by prior arrangements, be accepted late for the current week;
- (b) may, due to shortage of staff or to technical considerations, be delayed until conditions permit its processing.
- 7. Copy must not be submitted as part of a letter or a requisition. It must appear on a separate sheet of paper, on which there is no instruction or other extraneous matter.
- 8. (1) In cases where notices have to be published in tabular form, copy must be drafted exactly as it is to appear. If printed forms for any such notices are unavailable, advertisers must prepare their own forms. While it is not necessary to include the preamble, the box-headings must be there, and, where applicable, the number of the form; for example, "Insolvency Regulations—Form 3".
- (2) In the case of copy for tabular notices, the provision of subsection (2) of section 3 does not apply.
- 9. Copy for all advertisements, whether sent by post or delivered by hand, must be accompanied by a requisition or a letter which clearly sets out—
  - (a) the name and address of the advertiser; and
  - (b) the debtor's code-number, if any; and
  - (c) the required date or dates of publication.
- 10. (1) If a typographical error occurs in the Gazette, it is rectified as soon as possible by a correcting notice without charge to the ministry or department concerned, subject to the following conditions—
  - (a) that such error is reported to the editor within three months from the date of publication; and
