A surcharge of \$15 per kilolitre or part thereon will be imposed for all excess consumption.

If a consumer exceeds the allocation on three consecutive occasions, water supply will be cut off for the number of days equal to the excess consumption according to the allocation in that category, e.g., if the excess consumption amounts to 3 days of allocation, the water supply will be cut for 3 days.
- 16. This relaxation on water restriction does not mean that residents should now slacken their efforts to conserve water as the situation is still far from being favourable. Consumers are required to monitor their daily consumption of water by reading their water meters daily. This will help detect any unnecessary loss of water.
