COLLECTIVE BARGAINING AGREEMENT (MINE WORKERS)

Further Agreement

This further agreement, made and entered into in accordance with the provisions of the Labour Act [*Chapter 28:07*], between the Chamber of Mines of Zimbabwe (hereinafter referred to as the employers' organisation), on the one part, and the Associated Mine Workers Union in Zimbabwe (hereinafter referred to as "the trade union"), on the other part, being parties to the National Employment Council for the Mining Industry, to amend the Collective Bargaining Agreement: Mining Industry (General Conditions), 1990, published in Statutory Instrument 152 of 1990 (hereinafter referred to as "the Principal Agreement") shall be read as one with the Principal Agreement.

The National Employment Council for the Mining Industry has today, 26th February, 2021, reached an agreement to raise the NEC minimum rates/earnings for the Mining Industry by 22.22000000%.

1. RATES OF PAY

The Principal Agreement Statutory Instrument 152 of 1990 is amended by the deletion of Clause 1(a) and 1(b) of Schedule E and the substitution of—

"1. (a) Subject to the provisions of paragraph 1(b) the basic minimum earnings payable to employees with effect from 1st January, 2021 to 31st March, 2021, shall be as per Schedules below."

Collective Bargaining Agreement: Mining Industry

This agreement is subject to review on a quarterly basis, based on the prevailing economic situation in the Mining Industry.

The agreement carries an Exemption Clause as stipulated in the Principal Agreement, Statutory Instrument 152 of 1990, Clause 5 (Exemptions, Variations and Savings). Non-foreigncurrency generating companies, upon being granted an exemption, may be allowed to pay the full US dollar amount in ZW dollars equivalent using the official bank rate.

Those employers who are able to pay more than the NEC minimums are encouraged to do so.

All increases shall be based on the dollar value principle.

2. SERVICE INCREMENTS

The basic minimum earnings, prescribed in paragraph 1 (a) shall be increased as specified hereunder in respect of employees whose total length of service with the same employer amounts to two or more years.
