THE Government of the Republic of Zimbabwe has received financing from the African Development Fund, towards the Tax Accountability Enhancement Project (TAEP) and intends to apply part of the agreed amount for this grant to payments under the contract for development of forensic audit guidelines and audit programmes for audit of public sector entities.

The services included under this project are—

- (i) The development of the Supreme Audit Institution (SAI) Forensic Audit (including Digital Forensic Audits) guidelines for use in carrying out efficient Forensic Audits in Central Government, State Enterprises, Parastatals and Local Authorities;
- (ii) develop a checklist for monitoring contracted out Forensic Audits;
- (iii) train twenty (20) auditors in the use of Forensic Audits (including Digital Forensic Audits) guidelines and programmes;
- (iv) carry out trial runs and field tests of Forensic Audit (including Digital Forensic Audits) guidelines and programmes through on the job training and pilot audit.

The guidelines should be in line with Standards Board of Accountants, International Standards for Supreme Audit Institutions (ISSAIs) and other applicable best practices. These ensure transparency and accountability in the public sector through forensic audit reports which can stand in a court of law. The estimated period of execution is 75 days.

(4) Where any matter is added after the copy has been prepared, and such additional matter results in one or more sheets being inserted between those already numbered, all sheets must be renumbered from there onwards—not, for instance 7, 7b, 8, *et cetera*.

4. Photographic copy or copy produced on a duplicating machine may be accepted if it is abundantly clear.

5. (1) Should any copy—

- (a) exceed 10 pages of double-spaced typing on size A4 paper; or

Agreement

This further agreement shall be deemed to have come into effect on 1st July, 2021.

Clause 29 of the principal agreement is amended by the addition of the following sub-clause—

(2a) Gratuities for seasonal employees who are not offered employment in the following year will be calculated at the rate of pay applicable at the time the request for the gratuity is made.

6. Every employer shall, with effect from 1st March, 2021, pay each employee not less than the appropriate amounts as stated in Annexure “A” in this agreement.

7. Nothing contained in this agreement shall preclude companies from negotiating betterment of the agreed wage levels and any other working conditions at company works councils.
