In September, 2017, the EU and the UN launched a global partnership—the **Spotlight Initiative**(SI) to eliminate all forms of violence against women and girls worldwide. The SI’s main thrust is to, amongst others, operationalize the Sustainable Development Goals (SDG) relevant targets under, in SDG 5 Achieve Gender Equality and Empower All Women and Girls, SDG 3 Health and Well Being for All at All Levels and All Ages and SDG 16 Promote Inclusive Societies, Justice and Institutions for Sustainable Development and Promote Strong and Inclusive Institutions. The Government of Zimbabwe is one of the beneficiaries from the SI and has its implementing Ministries and agencies. One of the key outcomes of the SI is: Outcome 2 Strengthening Institutions.

The Office of the Auditor-General as an oversight institution is key in creating an enabling environment for accountability to SI issues. In pursuance of its mandate, the OAG aims to deliver high quality audit services to stakeholders on the management of these public resources through financial, compliance, value for money audits and special audits.

It is against this background that resources have been availed by the Spotlight Initiative Programme 6 under Outcome 2 to engage consultant services to develop Gender responsive audit programmes and guidelines for the Office of the Auditor-General. The Gender responsive audit programmes and guidelines will enable the OAG to conduct pilot audits in SI Ministries and entities.

The general objective of the task is to strengthen capacity of the Office of Auditor-General through development of Gender audit programmes and guidelines so that:

- Audits are conducted with gender lenses;
- There is enhanced accountability of public resources allocated for Sexual Gender Based Violence (SGBV), Harmful Practices (HPs) and Sexual Reproductive Health Rights (SRHRs).
- There is enhanced access of simplified audit reports for the targeted Spotlight Ministries and other entities; and
- The OAG plays a role in the independent assessment of the progress made towards achievement of SDGs.

The services include:

- (i) Develop and present an inception report, detailed work plan and methodology including an elaborate Gantt chart.
- (ii) Develop Gender Audit programmes and Guidelines for targeted Ministries, Department and Agencies.
- (iii) Develop and deliver training materials; and,
- (iv) Train 66 OAG management and staff on the developed audit programmes and guidelines.

The estimated period of execution is 25 days.
