**Background**

In line with the Devolution Agenda, and the Cluster

Development Initiative, market surveys were conducted in the ten (10) provinces of Zimbabwe. These surveys were conducted to identify export potential products and highlight activities to be done so as to stimulate cluster development.

In view of the above, and in line with the National Objective and ZimTrade Board Resolution on Export Diversification, ZimTrade intends to work on pilot cluster projects surrounding the development of products, market linkages and aggregator models, which are aimed at export enhancement. Through the development of export clusters, ZimTrade will promote exports by focusing resources, and advocating regulatory policies towards improving provincial contribution to economic growth as outlined in the National Export Strategy (NES).

**The objectives of the Cluster Development Program are:**

- To grow the export revenue per province and to create diversification.
- To create synergies to develop export potential.

ZimTrade now invites Registered and Eligible Consulting Firms with a proven record of accomplishment, qualification, and experience, to submit their expressions of interest in partnering with ZimTrade in the Development of export clusters in by province.

**Scope of work**

- Provide a list and justification (statistics) of the key products with established export potential or existing export products from the province, with potential for upscaling and/or developing of clusters.
- Identify and engage “Champion Producers”, associations, and other stakeholders suitable for the value chain development or cluster development.
- Map out the ideal models to be implemented in the province and recommend activities that can be done to stimulate/ invigorate export growth within the provinces.
- Provide a detailed report with product specifications and export destination together with seasonal price variation and demand and supply gaps.
- Engage the value chain actors (banks, processors/ manufacturers, farmers/SMEs, input suppliers) in identified products with export potential with a view to:
  - \* Share with them the export potential and the need to motivate them to up their production/fund production (in case of banks).
  - \* Motivate a case for market linkages/aggregation of products produced by individual farmers/SMEs for the identified exports.
  - \* Facilitate the development of the appropriate business model for the identified export cluster.
  - \* Motivate the case of the need of more out-grower schemes linked to the export opportunities.
  - \* Engage donors/DCPs and align their interests to export development.
- Provide a detailed report with:
  - \* List of value chain actors signing up to the market linkages and aggregator model with a clear confirmation of what they are committing to.
  - \* List of donors/DCPs committing to support the programme and quantification of their commitment.
  - \* Export potential in value and volume from the province and export markets.
  - \* Develop Implementation/ Action Plan for each product, especially to cover gaps in the production cycle.
  - \* Conduct physical visits to validate and assess the product potential. This is applicable especially to champion producers and associations. Evidence of capacity to produce is a pre-requisite.

Interested Consulting Firms should provide information demonstrating that they have the required experience, competences, skills, and qualifications relevant for performance of the services whether as individual firms, joint ventures or as consortia. The Consultants shall submit Company profiles, Company registration documents, Curriculum Vitae of key personnel and professional staff, brochures, description of similar assignments, experience

under similar environment or conditions. The Consulting Firm must demonstrate that they have fully established business offices. Prospective Consulting Firms may constitute joint-ventures where necessary to enhance their capacity to undertake the assignment.

(a) which is of national importance, and which is originated as a matter of urgent necessity, may, by prior arrangement, be accepted late for the current week;

(b) may, due to shortage of staff or to technical considerations, be delayed until conditions permit its processing.

7. Copy must not be submitted as part of a letter or a requisition. It must appear on a separate sheet of paper, on which there is no instruction or other extraneous matter.

8. (1) In cases where notices have to be published in tabular form, copy must be drafted exactly as it is to appear. If printed forms for any such notices are unavailable, advertisers must prepare their own forms. While it is not necessary to include the preamble, the box-headings must be there, and, where applicable, the number of the form; for example, "Insolvency Regulations—Form 3".

(2) In the case of copy for tabular notices, the provision of subsection (2) of section 3 does not apply.

9. Copy for all advertisements, whether sent by post or delivered by hand, must be accompanied by a requisition or a letter which clearly sets out—

(a) the name and address of the advertiser; and

(b) the debtor's code number, if any; and

(c) the required date or dates of publication.

10. If a typographical error occurs in the *Gazette*, it is rectified as soon as possible by a correcting notice without charge to

the ministry or department concerned, subject to the following conditions—

(a) that such error is reported to the editor within three months from the date of publication; and

(b) that the relevant copy, upon re-examination, is proved to be abundantly clear; and

(c) that the correction of such error is legally necessary.

(2) If a drafting error is not detected before publication, the originating ministry or department is required to draft its own correcting notice, take it to the Attorney-General for vetting and pay for such notice to be published.

(3) For the removal of doubt—

(a) a typographical error is made by a typographer;

(b) a typist's error is classed as a drafting error by reason of the fact that the officer responsible for drafting failed to check the typist's work.
