  - (a) advise the Commissioner appointed by the Sheriff, attending the sale of the manner in which he intends to make payment of the purchase-price and other costs and charges in terms of these conditions, and satisfy the Commissioner as to his bona fides and ability to meet his obligations; or
  - (b) effect payment to the Commissioner of the whole of the purchase-price in cash or by cheque or bank draft drawn to the order of the Sheriff.
- 9. The purchase-money, if not paid in full to the Commissioner at the conclusion of the auction shall be paid on or before the registration of the transfer of the property into the name of the purchaser, unless the Sheriff approves other arrangements for discharging the amount due by the purchaser.
- 10. The purchaser shall be liable to pay interest at the rate of twenty-five per cent, per annum in respect of any unpaid balance of the purchase-price with effect from seven days after the date of confirmation of the sale by the Sheriff.
- 11. - 13. The property shall be at the risk and profit of the purchaser from the date upon which the Sheriff confirms the sale and the Sheriff gives no warranty of vacant possession.

## NATIONAL EMPLOYMENT COUNCIL FOR THE AIR TRANSPORT INDUSTRY

## COLLECTIVE BARGAINING AGREEMENT: CHILD LABOUR AND LIST OF HAZARDOUS WORK

This further agreement, made and entered into, in accordance with the provisions of the Labour Act [Chapter 28:01], between the Employers' Association for the Air Transport Industry (hereinafter referred to as the "employers") and National Airways Workers Union (NAWU), Air Transport Union (ATU) and Zimbabwe Aircraft Maintenance Engineering Association (ZAMEA) hereinafter referred to as Employees Association for the Air Transport Industry) being parties to the National Employment Council for the Air Transport Industry, the Collective Bargaining Agreement for the Air Transport Industry, published in Statutory Instrument 55 of 1992, is amended as follows—

#### Amendment of Section 5

Section 3 (*Interpretation*) of Collective Bargaining Agreement for the Air Transport Industry (*S.1.55 of 1992*) herein after called the Principal CBA to be amended by insertion of these clauses—

"Child" means any person below the age of eighteen years (18);

- "Child labour" means work that is mentally, physically, socially, or morally dangerous and harmful to children; deprives children of the opportunity to attend school or forces children to leave school prematurely; requiring them to attempt to combine school attendance with excessively long and heavy work and work that is in violation of a country's minimum age laws;
- "Worst forms of child labour" means extreme forms of child labour which involve child slavery, exposure to serious hazards and illnesses;

- "Hazardous work" means ny type of employment or work which by its nature or the circumstances in which it is carried out is likely to jeopardise health, safety, or morals;
- "Light work" means work, which is not likely to jeopardise the education, health, safety, rest or the social, physical or mental development of a child.

#### Amendment of Section 23

Section 23 (Contract and Notice) of the Principal Act is to be amended by the insertion of subsection 14 on EMPLOYMENT OF YOUNG PERSONS as follows:

- (1) No employer shall employ any person in any position who is under the age of sixteen (16) years—
  - (a) as an apprentice;
  - (b) other than an apprentice to perform any work in an undertaking
- (2) No employer shall employ any person below the age of eighteen (18)—
  - (a) to perform hazardous work;
  - (b) to perform work in an undertaking other than as an apprentice or in conjunction with training at a vocational or technical training school.
- (3) No employer shall cause any person under the age of eighteen (18) to perform the following work—
  - any work which is likely to jeopardize or interfere with the education of the child or young person;
  - (b) any work involving contact with any hazardous substance, article or process;
  - (c) any work that exposes a child to electrically powered tools, cutting or grinding blades;
  - (d) any work that exposes a child to excess heat, cold, noise or whole-body vibration;
  - (e) any night shifts.

#### List of hazardous work

Hazardous work in the Air Transport Industry comprises of activities involving handling and transportation of dangerous goods which are identified as such by the International Civil Aviation Organisation (ICAO) from time to time. These are classified in 9 categories as tabulated below:
