Lotteries and Gaming (Fees) (Amendment) Regulations, 2021 (No. 7)

IT is hereby notified that the Minister of Home Affairs and Cultural Heritage has, in terms of section 65 of the Lotteries and Gaming Act [*Chapter 10:26*] as read with sections 16 and 23 of the Betting and Totalizator Control Act [*Chapter 10:02*], made the following regulations: —

1. These regulations may be cited as the Lotteries and Gaming (Fees) (Amendment) Regulations, 2021 (No. 7).

2. The Schedule to the Lotteries and Gaming (Fees) (Amendment) Regulations, 2003, published in Statutory Instrument 153 of 2003, is hereby repealed and the following is substituted—

Public Health (COVID-19 Prevention, Containment and Treatment) (National Lockdown) (No. 2) (Amendment) Order, 2021 (No. 15)

IT is hereby notified that the Minister of Health has, in terms of section 68 of the Public Health Act [*Chapter 15:17*], made the following order: —

1. This order may be cited as the Public Health (COVID-19 Prevention, Containment and Treatment) (National Lockdown) (No. 2) (Amendment) Order, 2021 (No. 15).

2. The Public Health (COVID-19 Prevention, Containment and Treatment) (National Lockdown) (No. 2) Order, 2020, published in Statutory Instrument 200 of 2020, is amended in section 4 ("National lockdown")(1) by the repeal of paragraph (d) and the substitution of -

- "(d) every Government establishment, and every local authority, shall be closed except to the extend directed by—
 - the responsible head of the Ministry or head of that establishment; or
 - (ii) the mayor or chairperson or chief executive officer of the local authority concerned;".
